Does St. Kitts already have a solar PV system?

St. Kitts will receive 30 - 35% of its annual electricity demandfrom a solar PV system as part of a new project. The solar and storage system will supply sustainable, solar energy with zero emissions and replace over 4,000,000 gallons of diesel per year. The energy will be provided under a fixed-price PPA for a period of 25 years.

How much does electricity cost in St Kitts & Nevis?

The electricity rates in the Federation of St. Christopher (St. Kitts) and Nevis are \$0.26 per kilowatt-hour (kWh). This is lower than the Caribbean regional average of \$0.33/kWh.

When will skelec start supplying Solar energy to St Kitts?

The project is scheduled to start construction in the second quarter of 2024 and start providing the solar energy to SKELEC in 2025. With the execution of the amended 25-year PPA and other related documents, the project is putting St. Kitts at the leading edge of renewable energy integration worldwide.

What does PPA stand for in St Kitts & Nevis?

The Government of St. Kitts and Nevis, along with SKELEC, the state-owned St. Kitts Electricity Company Ltd, have executed an amended Power Purchase Agreement (PPA) with SOLEC Power Ltd, a subsidiary JV of Leclanch \$\&\pm\$233;, for the solar photovoltaic and battery storage project located in Basseterre.

Ground has been broken on the St Kitts microgrid while negotiations and developments continue with the Nevis Geothermal project. The St Kitts facility to be comprised of 37.5MW solar PV and a 14.8MW/45.7MWh lithium-ion battery energy storage system is a major development for the nation and a landmark for the region.

On successful completion of this fully integrated solar photovoltaic system and a lithium-ion battery energy storage system (BESS), the facility will supply Saint Kitts with 30% to 35% of consumers" annual electricity

The project will provide the island of St Kitts with 35.7 MWp of solar capacity representing 30 - 35% of the annual electricity demand and 43.6 MWh of battery storage

St Kitts and Nevis started its TNA process in 2020 as part of the TNA IV project, at which point it initiated the process of deciding its priority sectors and technologies for both mitigation and adaptation.
