How to declare exports to China Customs?

Exporters can use custom brokersto declare exports to China Customs on their behalf. Alternatively, they can use the "National Single Window" to send their export declaration data to China Customs directly. Additionally, companies must submit their export declaration within 48 hours after transporting their goods to Customs' supervision areas.

What happens to goods after China Customs clears and releases them?

Goods can finally leave the countryafter China Customs clears and releases them. Businesses must submit necessary documents to ensure fast product release and export. These are the parties responsible for shipping goods within the country's borders. These are the people or companies producing goods for export.

Can a business export through China Customs?

First, businesses must register with China Customs to obtain the right for export and import. However, businesses without import and export rights can still export through foreign trade companies. Documents required for export declarations from China Customs include:

How can China Customs review and release goods?

They must also pay the fees and taxes (if any) levied on the goods early and submit all relevant documents. China Customs system can pass reviews and release goods automatically if the declaration falls under a "low-risk" category. But if Customs has doubts about the goods, they can transfer them for manual review.
