How many radio stations are in Saint-Pierre & Miquelon?

Saint-Pierre and Miquelon have fourradio stations; all stations operate on the FM band, with the last stations converted from the AM band in 2004. Three of the stations are on Saint-Pierre, two of which are owned by Outre-Mer 1è re, along with one 1è re station on Miquelon. At night, these stations broadcast France-Inter.

Does Saint-Pierre and Miquelon have a health care system?

Saint-Pierre and Miquelon's health care system is entirely public and free. In 1994,France and Canada signed an agreement allowing the residents of the archipelago to be treated in St. John's.

How did Saint-Pierre and Miquelon become a territory?

After the 1958 French constitutional referendum, the territory of Saint-Pierre and Miquelon was asked to choose one of three options: becoming fully integrated with France, becoming a self-governing state within the French Community, or preserving the status of an overseas territory; it decided to remain a territory.

In the past, Saint Pierre and Miquelon used only standard French vehicle registration plates, rather than plates in the format of six inches (150 mm) high by twelve inches (300 mm) wide used by most other jurisdictions in North America.
