The European Union Commission has approved a state aid schemeaiming to fund the rollout of over 9GW/71GWh of energy storage in Italy.

How much will Italy's energy storage program cost in 2023?

In December 2023, the EU greenlit Italy's energy storage program, earmarking a hefty investment of EUR17.7 billion. This initiative is anticipated to facilitate the construction of over 9GW/71GWh of energy storage systems (ESS).

Will Italy support a centralized electricity storage system?

The European Commission has approved, under the European Union's state aid rules, a EUR 17.7 billion scheme with which Italy intends to support the establishment and operation of a centralized electricity storage system.

How much subsidy does ESS offer in Italy?

This scheme offers a subsidy of up to 110%. According to ANIE data, as of 30 June 2023, a total of 3,045MW/4,893MWh of ESS capacity were installed in Italy, of which 776MWh of residential storage capacity were installed in Q2 of 2023, a 13% decline from the previous year.
