The NEA, the generator and distributor of electricity under the government of Nepal, traded surplus power of over 242 million units worth Rs 1.83 billion to India where power demand in monsoon is higher, in one month of the current fiscal year, said the NEA. Currently, the NEA is putting efforts to export an additional 111 megawatts of electricity.

NEA officials say Nepal has requested permission to export 1,200 MW this year. Nepal is in an energy surplus situation during wet months. The country, however, faces a shortfall of energy during the dry season when power generation by its run-of-river (RoR) projects shrink to nearly a third of installed capacity.

Nepal exported 1.95 billion units of electricity worth Rs. 17.06 billion to India during the last fiscal year (from July 17, 2023 to July 15, 2024). In the meantime, the Authority imported electricity worth Rs. 16.93 billion during the last fiscal year. In October 2021, India approved 39 MW power exports from Nepal to India for the first time.

The Himalayan country is going to supply an additional 251 megawatts (MW) of power to India, particularly through Bihar, thanks to a medium-term sales agreement involving 12 hydropower projects. This is ...
