Can an LLC do business in St Lucia?

LLC's can engage in many types of business depending upon any restrictions found in the Articles of Association. No business can be conducted within St. Lucia or any income derived from St. Lucia if the LLC wishes to be exempt from taxes. LLC's must appoint a local registered agent to accept legal notices and process of service.
