

Will PGE supply ESS batteries in Poland?

SEOUL, March 25, 2025 - LG Energy Solution announced today that it has signed an agreement with PGE, Poland's largest energy sector company, to supply 981 MWh of grid-scale ESS batteries between 2026 and 2027. Both companies will collaborate to establish a battery energy storage facility in Żarnowiec, Poland.

Which companies are building a battery storage facility in Poland?

Polish utility PGE Group has launched a tender for the design and construction of a battery storage facility with a minimum capacity of at least 900 MWh. Will PGE open a tender for a Bess project in Poland?

State-owned PGE Group, which is Poland's largest power producer by sales revenue and net profit, said earlier this month that it will open a tender for contractors to work on the country's biggest planned BESS project to date.

Is a 50MW project a key market for energy storage in Poland?

The acquisition of two 50MW projects totalling 400 MWh of capacity marks the developer's first entry into Poland, which is fast becoming a key market for energy storage in the Central and Eastern Europe region.

How big is Poland's energy transformation?

The innovative large-scale project to supply 263 MW and minimum output 900 MWh is a milestone in Poland's energy transformation. The storage will be four times bigger than the present biggest in Europe of 196 MWh recently launched in the UK and capable of supplying power to 300 thousand households for 2 hours.

Will Poland lead battery storage deployments in Eastern Europe?
