How will solar power help St Kitts and Nevis?

The Government of St. Kitts and Nevis, the state-owned St. Kitts Electric Company and Leclanché SA have broken ground on a landmark solar generation and storage project that will provide between 30-35% of St. Kitts baseload energy needs for the next 20-25 years while reducing carbon dioxide emissions by more than 740,000 metric tons.

Does St Kitts and Nevis have a national energy policy?

Yes,St. Kitts and Nevis has a National Energy Policy (NEP). The key provisions of this policy include connecting large-scale independent power providers and many distributed renewable energy systems to the electrical grid. Not all generation is made publically available; this chart provides known and referenceable data.

What is the St Kitts solar project?

Upon completion, the St. Kitts project will be the largest solar generation and energy storage system in the Caribbean and a model for other island nations worldwide. In its first year of operation, the system will generate approximately 61,300 MWh of electricity with a 41,500 metric ton reduction of CO 2 emissions.

How much does electricity cost in St Kitts & Nevis?

The electricity rates in the Federation of St. Christopher (St. Kitts) and Nevis are \$0.26 per kilowatt-hour (kWh). This is lower than the Caribbean regional average of \$0.33/kWh.
